

The "Mutual Benefits National Pepperoni Pizza Day" Sweepstakes Official Rules

SWEEPSTAKES PERIOD: The "Mutual Benefits National Pepperoni Pizza Day" sweepstakes begins at approximately 10:00:01am Eastern Time ("ET") on September 20, 2022 and ends at approximately 1:59:59pm ET on September 26, 2022 (the "Sweepstakes Period").

PRIZES: One (1) prize, \$50 Gift Certificate to a local pizzeria or restaurant that is a Mutual Benefits Local Business Partner.
